1. The name of the Corporation is WILLIAMS COMPANY OF TAMPA, INC.
2. The following amendments to the Articles of Incorporation were adopted by the shareholders of the Corporation on January 30, 2001, in the manner prescribed by the Florida General Corporation Act.:

A. The name of the Corporation is changed to JANET SAUNDERS, INC.
