

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ROBERTS LUMBER COMPANY, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, corporation adopts the following Articles of Amendment to its Articles of In

1. Article III of the Articles of Incorporation is amended to read:

ARTICLE III

The authorized capital stock of this Corporation shall consist of twenty thousand (20,000) shares of common stock with ten cents (\$.10) par value. The Class of common stock shall be composed of two hundred (200) shares of voting stock and nineteen thousand eight hundred (19,800) shares of non-voting stock. The common stock, both voting and non-voting, shall have identical rights except as to rights to vote. Said stock shall be issued for such consideration as may be determined by the Board of Directors.
