**AUTHORIZED SHARES**

The total number of shares of all classes of Common Stock which the Corporation shall have authority to issue is One Thousand (1,000), of which TEN (10) shares having a par value of \$1.00 shall be of a Class "A" voting designated common stock (the "Class-A Voting Common Stock") and Nine Hundred Ninety (990) shares having a par value of \$1.00 are to be of a Class "B" Non-voting designated common stock (the "Class0B Non-Voting Common Stock")."


