ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
LAISHLEY FARM SERVICE, INC.

To: Department of State
Tallahassee, FL 32314

Pursuant to the provisions of Florida Statutes 607.1006, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1) The name of the corporation is **LAISHLEY FARM SERVICE, INC.**

2) The following amendments of the articles of incorporation were adopted by the shareholders and directors of the corporation on October 27, 2000 in the manner prescribed by the Florida Business Corporation Act:

That the name of the corporation, **LAISHLEY FARM SERVICE, INC.** shall be amended to **LAISHLEY MARINE, INC.**

3) The number of share of the corporation outstanding at the time of adoption was one hundred (100); and the number of shares entitled to vote on the amendments was one hundred (100).
