
TO THE SECRETARY OF THE STATE OF FLORIDA:

IN WITNESS WHEREOF the undersigned has of this 6th day of September, 2000 made and subscribed the Articles of Amendment of Articles of Incorporation.

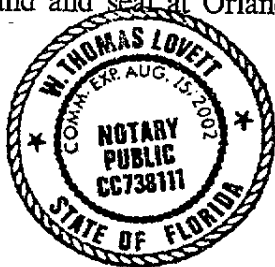
