#### AMENDMENT TO **ARTICLES OF INCORPORATION OF** MATHEWS CORPORATION

FILED Pursuant to Section 607.1006(1) of the Florida Statutes, the Articles of Incorporation Mathews Corporation, as amended, a Florida corporation (the "Corporation"), are hereby harther amended as follows:
