

Pursuant to Section 607.1403 of the Florida Statutes the undersigned Corporation adopts these Articles of Dissolution.


- A. The name of the Corporation is Steeler, Inc.

- D. These Articles of Dissolution will take effect upon filing with the Secretary of State.




