The dissolution was authorized on February 28, 2001.

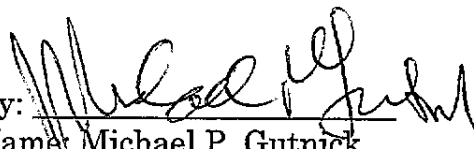
**ARTICLE III**
