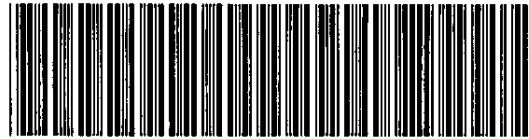



STATEMENT OF FACTS

I am employed as a Licensing Manager with Charlotte County Florida. I have been employed by Charlotte County since October 1988. In June 2014, I was made aware by my Manager, Building Official James Evetts, that he was contacted by the Department of Business and Professional Regulation Program Administrator Sergio Gonzalez that I am being shown as an officer of Service Star Enterprise Inc. During this same period, a public records request was submitted by Melanie Payne, a Consumer Advocate of the Fort Myers News Press requesting any and all public records related to Service Star and my emails for a specific date range. I did not file the amendment to the corporate records nor did I allow anyone permission to list me as an officer. I will explain below the reasons I believe someone assumed my identity and listed me as an officer as retribution for performing my duties as an employee of Charlotte County. Once notified of this, I immediately contacted the Charlotte County Sheriff's Office and the Attorney General counsel, Robert Follis.

I supervised the Investigator and or personally conducted investigations into this company, its three (3) qualifiers and its predecessor companies. The results of this investigation caused the License holders to lose their ability to conduct business in Charlotte County and subsequently the state of Florida. In addition, cases were referred to the Attorney General's Office for investigation of violations of the Florida Deceptive and Unfair Trade Practices Act. I was a witness for the state of Florida due to my extensive investigations against Service Star Enterprises Inc., and its officers and or owners, Salvatore and Darrielle Tavoracci. The Judge ruled in favor of the state which resulted in a seizure of all assets belonging to the company.

Subsequently the case was referred to the Department of Agriculture, Law Enforcement division. Investigator Daniel Hopkins investigated the case and found that the payment for the amendment listing me as an officer was made via money order with no return information or payee name.
