TO
THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, Wedgefield Development Corporation, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Wedgefield Development Corporation.
2. The following amendments to the Articles of Incorporation of the Corporation are hereby adopted, effective with the filing of these Articles of Amendment to the Articles of Incorporation with the Florida Secretary of State:

Article I is hereby deleted in its entirety and the following is substituted therefore:

ARTICLE I

The name of this corporation shall be Southeast Community Development Corp.

3. The amendment hereby effected was adopted by Unanimous Written Consent of the Shareholder and the Board of Directors dated May 29th 1997.
4. These Articles of Amendment to the Articles of Incorporation are to be effective as of May 27, 1997.
5. All other provisions of the Articles of Incorporation remain unchanged and in full force and effect.
