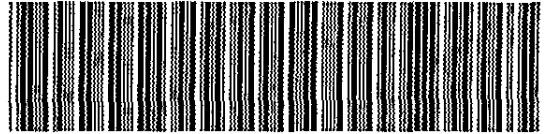

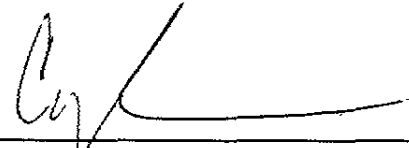

TO THE ARTICLES OF INCORPORATION OF

The undersigned, certifies that:
