# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORORATION OF MILLER INDUSTRIES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, MILLER INDUSTRIES, INC., a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Miller Industries, Inc. (hereinafter called the "Corporation").
- 2. Article Lof the Corporation's Articles of Incorporation is deleted in its entirety and replaced with the following new Article I:

#### "ARTICLE I Name

The name of the corporation is Adriatic Properties Corporation (the "Corporation")."
