## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JEWELERS TRADE SHOP, INC.



Pursuant to Sections 607.1001 and 607.1006 of the Florida Business Corporation Act, JEWELERS TRADE SHOP, INC., a Florida corporation (the "Corporation"), hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation as follows:

- 1. The name of the Corporation is Jewelers Trade Shop, Inc., and the corporate document number of the Corporation is 267355.
- 2. The Articles of Incorporation are hereby amended by amending and restating section Three to read as follows:

## THREE

This corporation is authorized to issue one hundred (100) shares of Class A Voting Common Stock at \$100.00 par value per share and one hundred (100) shares of Class B Nonvoting Common Stock at \$100.00 par value per share. Except for voting rights, all shares (both Class A and Class B) shall have identical rights and entitlements, including rights to both operating and liquidating distributions. The owners of Class A Voting Common Stock shall be entitled to one vote (on all matters for which stockholders of the corporation shall vote) for each share of Class A Voting Common Stock owned by such stockholder. Owners of Class B Nonvoting Common Stock shall not be entitled to any vote with respect to shares of Class B Nonvoting Common Stock.
