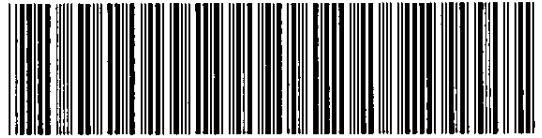

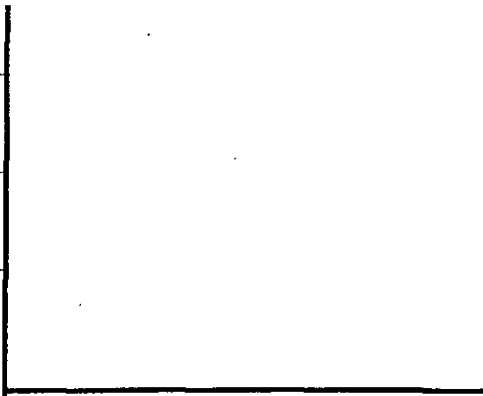


3. Except as expressly amended hereby, the Articles shall be and remain in full force and effect. These Articles of Amendment shall be effective on January 4, 2016.


