ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
INVESTORS REAL ESTATE SERVICES, INC.

Article III of the Articles of Incorporation of Investors Real Estate Services, Inc. was amended by the corporation's sole shareholder on January 11, 2004. The corporation is filing these articles of amendment to articles of incorporation pursuant to F.S. 607.1006.

1. Article III is hereby amended to read as follows:

3.1) Number of Authorized Shares. The aggregate number of shares the Corporation shall have authority to issue is One Thousand (1,000) shares of Class A voting common stock having no par value per share and Five Million (5,000,000) shares of Class B nonvoting common stock have no par value per share. Each class of stock shall have identical rights to distribution and liquidation proceeds.

2. The foregoing amendment to articles of incorporation was duly adopted by the sole shareholder on January 11, 2004.
