

ARTICLES OF AMENDMENT TO THE ARTICLES
OF INCORPORATION OF

Pursuant to the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Paragraph 3 is hereby restated as follows:

This Corporation is authorized to issue One Hundred (100) shares of voting common stock having One Dollar (\$1.00) par value and One Hundred (100) shares of non-voting common stock having One Dollar (\$1.00) par value.

The shares of this Corporation are not to be divided into classes.

This Corporation is not authorized to issue shares in series.

2. The foregoing Amendment was adopted by the unanimous consent of all of the Shareholders of the Corporation on the 12th day of May, 1997, in the manner prescribed by the Florida General Corporation Act.


