# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION



Pursuant to Section 607.1006, Florida Statutes, the Undersigned Corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: The name of the corporation is:

### THE ALAN COMPANY

SECOND: The following amendment to the articles of incorporation was adopted by the corporation:

The common stock is redeemable by the corporation at the option and discretion of the board of directors, in whole or in part, at any time on ten (10) days' notice in payment of estate taxes, interest on estate taxes, funeral expenses or administration expenses of a deceased shareholder or the transferee of a deceased shareholder under the provisions of Internal Revenue Code 303. The redemption price shall be the value of the stock for federal estate tax purposes as finally determined in the federal estate tax proceeding relating to the estate of such deceased shareholder. However, no such redemption will be made when the corporation is insolvent or when that redemption would render the corporation insolvent, or would reduce the corporation's net assets below the aggregate amount payable to the holders of any shares having prior or equal rights to the assets of the corporation on involuntary dissolution.

The corporation must give notice of the redemption by call and written or printed notice. The notice of redemption must set forth;

(a) The class or series of shares or part of any class or series of

shares to be redeemed.

- (b) The date fixed for redemption.
- (c) The redemption price.
- (d) The place at which the shareholders may obtain payment of the redemption price on surrender of their share certificates.

A copy of the notice of redemption must be mailed, postage prepaid or hand delivered, to each holder of shares to be redeemed, of record as of the date of mailing or as of the record date fixed in accordance with the bylaws, addressed to the holder, at his or her address appearing on the corporation's books or given by him or her to the corporation for the purpose of notice, or if no such address appears or is given, at the place where the principal office of the corporation is located, not less than ten (10) days before the date fixed for redemption.

In case of a partial redemption of the common stock, the redemption shall be pro rata among the various holders who qualify for redemption under Internal Revenue Code 303.

The redemption payments may be made from any legally available source of funds and may be made in cash or by promissory note with interest to exceed the applicable federal rate and payment in full within fifteen (15) years of the redemption date.

On or before the date fixed for redemption, each holder of shares called for redemption shall surrender his or her or its certificate for such shares to the corporation at the place designated in the redemption notice and shall be entitled to receive payment of the redemption price. If less than all of the shares represented by a surrendered certificate are redeemed, a new certificate shall be issued representing the unredeemed shares.

The amendment was adopted by the shareholders of the corporation on the 26th day of April, 2000.
