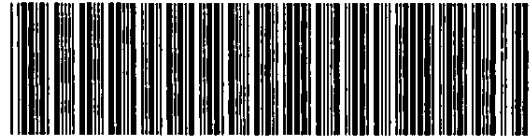

ARTICLES OF INCORPORATION
OF

Pursuant to Section 607.1006, Florida Statutes, (2012), Dunson Harvesting, Inc. (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is: Dunson Harvesting, Inc.
2. The Corporation has fewer than 35 shareholders.
3. The following amendment to the Corporation's Articles of Incorporation has been adopted by the shareholders in the manner prescribed by Section 607.1003(6), Florida Statutes, (2007):

RESOLVED that the first sentence of Article VII of the Corporation's Articles of Incorporation is deleted and replaced with the following:

This Corporation shall have no less than one director. The number of directors may be increased or decreased from time to time, as provided in the Corporation's bylaws, but shall not be less than one or more than three. The number of directors shall be set forth in the Corporation's bylaws.

4. The number of votes cast for the amendment by the shareholders was sufficient for approval. No more than one voting group was entitled to vote on the amendment.
5. The amendment was adopted by the shareholders on December 5, 2012.

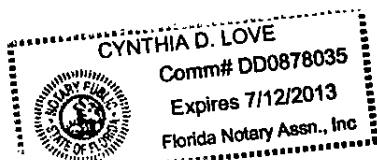
