

AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

TOWN AND COUNTRY INDUSTRIES, INC.

1. Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I Name

The name of the corporation is Town and Country Industries, Inc.

ARTICLE II <u>Duration</u>

This corporation shall have a perpetual existence, unless dissolved according to law.

ARTICLE III Purpose

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, as amended and in force from time to time.

ARTICLE IV Capital Stock

The Corporation is authorized to issue one thousand five hundred (1,500) shares of one dollar (\$1.00) par value common stock which shall be designated "Common Voting Shares"; and fifteen thousand (15,000) shares of one dollar (\$1.00) par value common stock which shall be designated "Common Non-Voting Shares." The Common Voting Shares and Common Non-Voting Shares shall be entitled in all respects to equal rights and privileges except that each share of Common Voting Shares shall be entitled to one (1) vote and each share of Common Non-Voting Shares shall be Non-Voting stock.

ARTICLE V Principal Office; Registered Office and Agent

The street address of the initial principal office and registered office of this corporation is 400 W. McNab Road, Fort Lauderdale, Florida 33309, and the name of the registered agent of this corporation at that address is Timothy O'Connor.

ARTICLE VI Initial Board of Directors

1. This corporation shall initially have two (2) directors. The number of directors may be increased or decreased from time to time by the By-Laws, but shall never be less than one (1). The name and address of the initial directors of this corporation are:

- 2. The number of shares of the Corporation outstanding at the adoption was one thousand five hundred (1,500), and the number of shares entitled to vote thereon was one thousand five hundred (1,500).

- 4. These Amended Articles of Incorporation were adopted on the 9th day of July, 2004.
- 5. The holders of Common Shares shall exchange each share of such stock for one (1) share of Voting Common stock and ten (10) shares of Non-Voting Common stock.
- 6. These Amended and Restated Articles of Incorporation shall become effective immediately upon filing with the Department of State of Florida.
