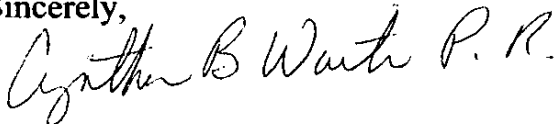
Dear Michelle,
