# SECOND AMENDMENT TO THE ARTICLES OF INCORPORATION OF PIPPIN TRACTOR AND EQUIPMENT, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the Articles of Incorporation of Pippin Tractor and Equipment, Inc., a Florida corporation, filed in Tallahassee on January 3, 1964 and as amended on December 11, 1989 are hereby amended as follows:

1. Article III of the Articles of Incorporation is hereby deleted and the following is substituted in lieu thereof:

#### ARTICLE III

The maximum number of shares of par value stock in this corporation shall be two million five hundred thousand (2,500,000) shares of Common Stock. The Common Stock shall have a par value of ten cents (.10) per share and shall be fully paid and non-assessable. The holders of each share of Common Stock shall have one vote for each share owned.

2. Article VII of the Articles of Incorporation is hereby deleted and the following is substituted in lieu thereof:

#### ARTICLE VII

The corporation may operate with no less than one (1) Director and no more than three (3) Directors, as more fully set forth in the By-Laws, and in accordance with the laws of the State of Florida.

- 3. The foregoing Amendments to the Articles if Incorporation were duly adopted by the Stockholder and Directors of the corporation on October 1, 1999.
- 4. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
