The undersigned, the President of DiPrima Enterprises, Inc., a Florida corporation ("Enterprises") and the President of Di Prima Construction Corporation, a Florida corporation ("Construction"), hereby certifies in connection with the merger of DiPrima Enterprises, Inc. and Di Prima Construction Corporation that:

- 1. Plan of Merger.
 - A. The name and state of incorporation for each of the constituent corporations of the merger is as follows:

written consent on November 1, 1999, and (b) the directors of Construction during a special meeting held on November 1, 1999.

The terms of merger contained in these Articles of Merger have been approved, adopted, certified, executed and acknowledged by (a) the shareholders of Enterprises by unanimous written consent on November 1, 1999, and (b) the directors of Enterprises during a special meeting held on November 1, 1999.
