**ARTICLES OF INCORPORATION OF
CARLTON TERRACE CORPORATION**

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I Name:

The name of this corporation is:

CARLTON TERRACE CORPORATION

a Florida corporation

ARTICLE II Nature of Business:

A. The specific nature of the business to be transacted is to do any or all of the things mentioned herein, viz:

(1) This corporation shall be operated for the purpose of operating and managing a single housing project on a non-profit basis and in the interest of and for the housing of its members and other lawful occupants.

(2) All assessments paid by individual owners to the corporation for maintenance, taxes, operation, mortgage payments, if any, insurance, etc., shall be utilized by the corporation in paying the obligations of the corporation as authorized by the Board of Directors. Any excess moneys received from assessments paid by individual owners and held by the corporation at the conclusion of its taxable year, whether calendar or fiscal, shall be used by said corporation to apply against future expenses of the corporation, or shall be returned to the owners in proportion to the percentage of assessments paid by each owner.

B. The general nature of the business to be transacted by this corporation is:

(1) To acquire land, improved or unimproved, by purchase and to improve, develop, hold and enjoy real property in fee simple and in leasehold estate and to contract for the construction of building or buildings on land acquired.

(2) To borrow money and issue evidence of indebtedness in furtherance of any or all of the corporate business; to secure loans by mortgage, pledge, deed of trust or other lien; to assume an existing indebtedness or mortgage.

(3) To sell, convey, assign, mortgage or lease any real property and any personal property.

(4) To provide housing in the form of apartment units on a co-operative basis for the shareholders of the corporation and whenever necessary to lease as landlord apartment units within the apartment buildings owned by the corporation.

To operate the apartment buildings owned by the corporation, subject to provisions of the By-Laws of the corporation, in a manner that will provide the Tenants with satisfactory living conditions.

(5) To have all the general powers, rights and privileges provided by the laws of the State of Florida, particularly Chapter 608 of Florida Statutes.

ARTICLE III Capital Stock:

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

Six Hundred Forty-six (646) shares of the par value of One Dollar (\$1.00) per share.

ARTICLE IV Initial Capital:

The amount of capital with which this corporation will begin business is Five Hundred Dollars (\$500.00).

ARTICLE V Term of Existence:

This corporation is to exist perpetually.

ARTICLE VI Address:

The initial post office address of the principal office of the corporation is:

The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VII Directors and Officers:

This corporation shall have three directors initially. The number of directors may be increased or diminished from time to time, in accordance with the By-Laws, but shall never be less than three. The corporation shall have three officers initially, a president, a vice president, a secretary-treasurer. The number of officers may be increased from time to time in accordance with the By-Laws of this corporation.

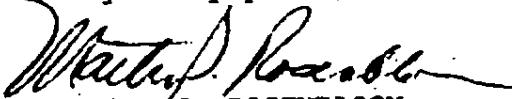
