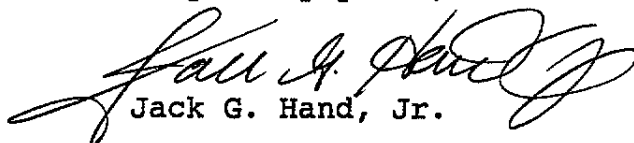
Ladies and Gentlemen:
