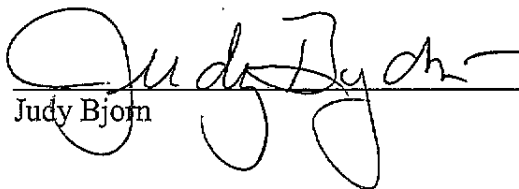
1. The current name of the corporation is Ditch Witch Trencher, Inc. of Florida.

J.B. Equipment Specialists, Inc.

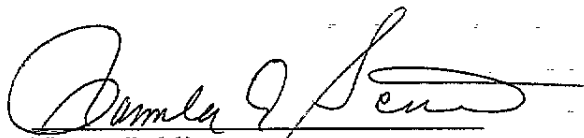

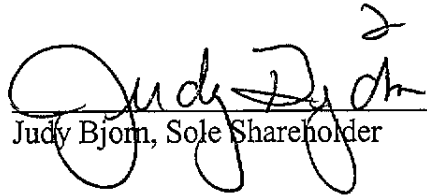
