#### ARTICLES OF AMENDMENT

TO THE

#### ARTICLES OF INCORPORATION

OF

The undersigned, David M. Pomfret, IV, President, and Kyle C. Varona, Secretary, of FAHEY PEST MANAGEMENT, INC. hereby certify that:

- 1. They are the current President and current Secretary of FAHEY PEST MANAGEMENT, INC., a Florida corporation, whose Articles of Incorporation were filed with the Department of State, State of Florida, on December 31, 1964.
- 2.
