ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION SUPPLY ENGINEERING AND FINANCE CORPOR

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation.
