**FIRST:** Amendment adopted:

The First Article shall be amended by deleting the present First Article in its entirety and substituting the following in lieu thereof:

"**FIRST:** The name of the corporation is Scripps Treasure Coast Publishing Company."

**SECOND:** The date of the Amendment's adoption is February 28, 2000.
