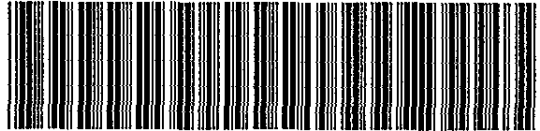

Article I. The name of the corporation is **ORTEGA UTILITY CO**.
