ARTICLES, OF AMENDMENT u to ARTICLES OF INCORPORATION of BERGERON LAND DEVELOPMENT, INC.

Pursuant to the provisions of 607.1006, Florida Statutes, the undersigned Florida profit corporation adopts the following articles of amendment to its articles of incorporation.
