Pursuant to the provisions of section 607.1006, Florida Statutes, Air Engineers, Inc., a Florida profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Amendment adopted:

Article VII is deleted in its entirety and replaced with the following:


“ARTICLE VII. DIRECTORS

The number of Directors shall be established from time to time, by the Bylaws of this corporation.”

SECOND: The date of the amendment’s adoption: October 9, 2000.
