ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FIREDOOR CORPORATION OF FLORIDA

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:
