To Whom It May Concern,

It was a total surprise and bewilderment when I received this Dissolution of my corporation. I inherited this corporation 10 years ago when my father passed away. I have always sent in all of my required paperwork to my accountant and sent the checks applicable for all of my corporate obligations, Unemployment Tax, Federal and State Tax and my Uniform Business Report. There is only one holding in the corporation, a Section 8 Housing Project. This year was a bit different than previous years in pertaining to my business affairs. Usually, I receive the bills and personally forward everything regarding the corporation to my accountant overseeing the paperwork personally before it leaves me. He fills out my forms and sends them back with instructions on what to pay whom and how much. This year, however, my Father-In Law passed away after a short illness and my whole family was tossed upside down. My Mother-In Law was alone in another state and my husband and I took turns trying to help her pull her life together. When I was away from home I instructed my 17 year old daughter to package all of my mail pertaining to Arlington Apartments and send it every 2 weeks to my accountant. I did talk to her and my accountant and I thought

all was going just fine. Until, of course, I received this Dissolution I had no clue that something very important did not

make it to the accountant.

After receiving this Dissolution when I returned from my Mother-In Law's home I was horrified. I have always sent in all of my Uniform Business Reports back in a timely fashion. As my panic set in I called my accountant and went to his office to find out just what could have happened. We went through every piece of mail my daughter received for me and forwarded to him and that only document was missing. (We hope there are no other important documents missing.) I mean we went through everything regarding the corporation and my accountant's office. We have come to the conclusion that we did not receive the 2001 Uniform Business Report this year in the mail. There is no other explanation, of course, I did have to trust my 17 year old daughter to package everything up that came in the mail. After some yelling and crying by my daughter, swearing she sent everything that came in the mail to the accountant, the conclusion is that there was either no report received at this mailing address (perhaps somehow it went to the property address of the apartments listed in Melbourne FL) In defense of my daughter, my accountant explained that he had been very sick throughout March and April and that his absence from the office caused several other unrelated problems at his office. He said it could possibly been an error made by him or by his assistant, as they were in a bad paperwork backlog upon his return to work over the summer.

In August we refinanced the property and Arlington Apartments Inc. went through much scrutiny. We even had to get a letter stating that the corporation was in good standing. We had Corporate Access Inc. in Tallahassee run our information and we were "In Good Standing" on August 29, 2003. We were dissolved on Sept 19th and did not receive the letter informing us of the dissolution until October 22nd. We could never have dreamed that we were late with our report or fees and then 20 days later be dissolved.

This has been a very trying year for us and I am hoping that since before now we have been in good standing and always on time, is there a way for us to appeal our the fine?

I file all of my taxes and all other information under this other number. Could it be that somehow this mistake in EIN numbers has caused this problem in our not receiving the form from you?
