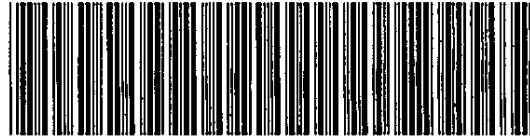



Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, to correct the Articles of Amendment to the Articles of Incorporation of Electric Services, Inc that were filed March 26, 2015.

FIRST: ARTICLE III is amended to read as follows:

ARTICLE III – CAPITAL STOCK

The maximum number of shares that this corporation shall be authorized to issue and have outstanding at any one time shall be limited to One Thousand (1,000) shares of Voting Common Stock with a par value of \$1.00 per share and Nine Thousand (9,000) shares of Non-Voting Common Stock with a par value of \$1.00 per share, and will be designated as Class A Common Stock authorized for issuance as Small Business Stock under Section 1244 of the Internal Revenue Code.

SECOND: The date of adoption of the Amendment was:
March 10, 2016.

THIRD: The Amendment was adopted by the shareholders and the number of votes cast for the Amendment was sufficient for approval.
