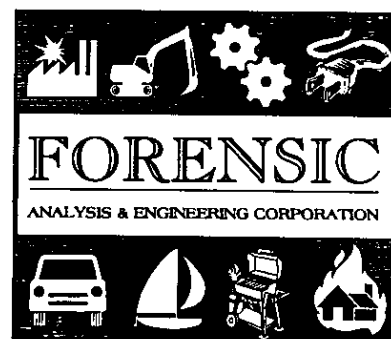

Resubmittal of a corrected version of a previously submitted but incomplete Annual Report form as requested by your office during a telephone conversation held today

Dear Department Representative:

It came to our attention earlier today that our long standing corporate status in the State of Florida was in jeopardy because of our failure to properly receive and reply to a letter that the Division of Corporations sent to us a few months ago. We now understand that the original corporate license renewal form that we submitted timely last April contained an error where we failed to designate the official corporate status of our then newly appointed official registered agent, Jane L. Kochan as a **Director** of the firm. By this letter we hope to correct this oversight and provide you with factual reason(s) why we failed to timely respond.

My father, Stanley S. Kochan was the former registered agent for the firm in the State of Florida until his recent death earlier this year. He acted both as our official agent and received any official mail for the firm as part of his responsibilities. Unfortunately, with his death, our ability to retrieve mail from his P.O. Box, which is currently listed as the address of record in your files, was not possible due to U. S. P.O. regulations. Thus we were not aware of the receipt nor did we know about any of your mailings since early May of this year.

Our newly designated registered agent, Jane L. Kochan, is capable of receiving all necessary corporate mail on our behalf. As your current records will show, FAEC previously submitted the appropriate change of Registered Agent information with her address as 100 Pierce Street, Penthouse, Clearwater, Florida 33756-5140. If possible, we would request that the firm's official address of record be changed to the above and that all official correspondence be sent to the address of Ms. Jane Kochan.

I trust that the above explanation of the factual causation of our delay in responding to your department's letters will be sufficient to mediate our cause and allow you to proceed to complete the firm's annual corporate filing. We have enjoyed our long standing corporate status in the State of Florida and wish to preserve our business entity for many years to come. Please advise if there is any further action needed for us to come into full compliance with Florida's statutes.
