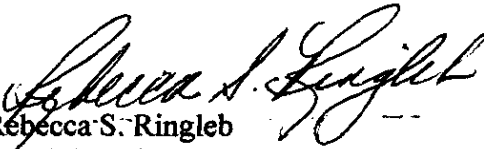
Gentlemen:
