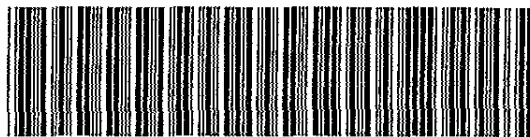



5. All the remaining property and assets of the corporation have been distributed to its sole shareholder, Frances Fayann Holmes, in accordance with her respective rights and interests.


6. There are no actions pending against the corporation in any court, administrative agency or other tribunal in any forum and no such action is threatened.


7. The dissolution of the corporation was authorized by its shareholders on July 23 2003.

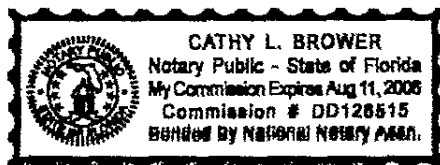
