The undersigned officers of this Corporation certify that pursuant to Resolutions unanimously adopted by all of the shareholders and all of the directors of this Corporation under F.S. Chapter 607, the Florida Business Corporation Act, this Corporation hereby adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I - NAME
