Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned corporation executes the following Articles of Dissolution:


**FIRST:** The name of the corporation is American Automated Services, Inc. (hereinafter referred to as the "Corporation").
