This is to certify, pursuant to Sections 607.1003 and 607.1006, Florida Statutes, that:

- 1. The name of the corporation is Tile Contractors Supply Company of Florida, Inc.
- 2. The following is a true and complete copy of the Amendment to Article THIRD of the Articles of Incorporation:

"THIRD: The maximum number of shares of capital stock which this corporation is authorized to issue or to have outstanding at any one time is 10,000 shares of common stock having a par value of \$.01 per share.

"Each share of the no par value common stock of this corporation issued and outstanding as of the effective date of this amendment is hereby reclassified and changed into two hundred fifty (250) fully paid and nonassessable shares of \$.01 par value common stock of this corporation, and each holder of record of a certificate for one or more shares of common stock of this corporation as of the effective date of this amendment shall be entitled to receive as soon as practicable upon the surrender of such certificate, a new certificate or certificates representing two hundred fifty (250) shares of \$.01 par value common stock for each one share of no par value common stock per share represented by the certificate of such holder."

- 3. The date of adoption of the foregoing amendment was July 15, 2004.
- 4. The foregoing amendment was approved by both the directors and the common shareholders of the corporation. The number of votes cast for the amendment by both the directors and the common shareholders was sufficient for approval.
