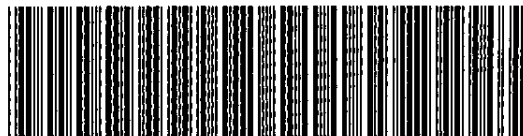

ARTICLES OF INCORPORATION

This is to certify, pursuant to Sections 607.1003 and 607.1006, Florida Statutes, that:

1. The name of the corporation is Tile Contractors Supply Company of Florida, Inc.

2. The following is a true and complete copy of the Amendment to Article THIRD of the Articles of Incorporation:

"THIRD: The maximum number of shares of capital stock which this corporation is authorized to issue or to have outstanding at any one time is 25,000 shares of common stock having a par value of \$.01 per share.
