**ARTICLES OF DISSOLUTION

Pursuant to Section 607.1403, Florida Statutes, **Butler Cleaners, Inc.**, a Florida corporation, submits the following Articles of Dissolution:

**ARTICLE I**

The name of the corporation is **Butler Cleaners, Inc.** (the "Corporation"). The document number of the Corporation is 314743.
