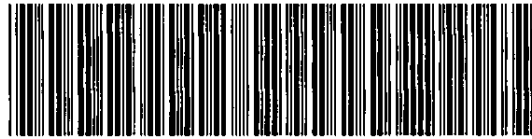

ARTICLES OF DISSOLUTION


ALLIED PRINTING, INC., a Florida corporation, executes the following articles of dissolution pursuant to section 607.1403 of the Florida Business Corporation Act:
