Torode Oil Company, Inc., a Florida corporation, executes the following articles of dissolution pursuant to Section 607.1403 of the Florida Business Corporation Act:


FIRST: The name of the corporation is Torode Oil Company, Inc., (document number 318589) (the "Corporation").
