THESE ARTICLES OF AMENDMENT are made and executed for and on behalf of E & G FOOD CO., a corporation organized and existing under the laws of the State of Florida, by virtue of Articles of Incorporation filed with the Department of State, Division of Corporations, State of Florida (the "Department"), on October 20, 1967, under Charter Number 322215, and amended several times by Certificates of Amendment filed with the Department, TO AMEND said Articles of Incorporation, to completely delete Article III of the original Articles of Incorporation, as amended, and to replace same by the following, to wit:

**ARTICLE III**

The maximum number of shares of stock which the Corporation shall have outstanding at any time shall be three million (3,000,000) shares, all of which shall be common shares with a par value of One Dollar (\$1.00) per each share. All or any part of the capital stock may be paid in lawful monies of the United States of America, in real or personal property, or in services at a true value thereof.

These Articles of Amendment were adopted on February 28, 1997, pursuant to Section 607.1006 of the Florida Statutes by written consent of all the directors and all of the

shareholders of the corporation eligible to vote manifesting their intention that the foregoing amendment to the Articles of Incorporation be adopted.

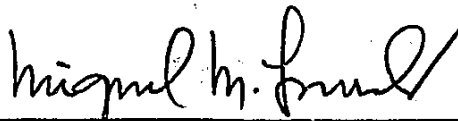
