

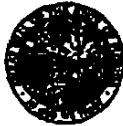



We are the accountants for the above-referenced taxpayer and are requesting on their behalf for a corporation reinstatement. Please be advised that the taxpayer was unable to file the Uniform Business Report form due to the fact that the company was sold and was moved from the previous location. For this reason, the taxpayer never received the UBR annual report form. Additionally, the taxpayer's bookkeeper left the company in 2002 and was not replaced. Thus the taxpayer was unaware of the filing requirement. Please be advised that the taxpayer has instituted office procedures (tracker due dates) to ensure proper filing and payment of the UBR in the future.

In light of the above reasons, we respectfully request for an abatement of the penalties and for the corporation to be reinstated. Enclosed is a check in the amount of \$300.00 in payment of the last 2 years filing fees.
