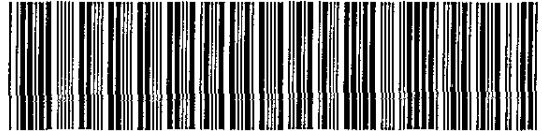

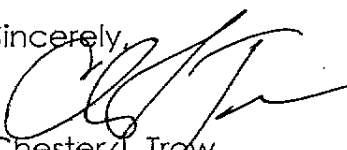

**ARTICLES OF DISSOLUTION
PURSUANT TO SECTION 607.1403, FLORIDA STATUTES**

Pursuant to the provisions of Section 607.1403, Florida Statutes, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving this corporation:
