



ARTICLES OF INCORPORATION OF

C.W. FISCHER ELECTRIC, INC.

Purusant to Section 607.1007, Florida Statutes, as amended, the following Amended and Restated Articles of Incorporation for C.W. Fischer Electric, Inc., a for-profit corporation, is hereby submitted for filing:

- 1. The name of the corporation is C.W. Fischer Electric. Inc. (the "Corporation").
- 2. The Corporation's Articles of Incorporation are hereby deleted in their entirety and replaced with the following:

ARTICLE I

The name of the Corporation is C.W. Fischer Electric, Inc.

ARTICLE II

The purpose of the Corporation is to engage in any lawful act or activity for which a Corporation may be organized under the Florida Statutes.

ARTICLE III

The name and address, in the State of Florida, of this Corporation's agent for service of process is:

ARTICLE IV

The Corporation is authorized to issue only one class of shares of stock which shall be designated as common stock; the total number of shares which the Corporation is authorized to issue is 100 shares, \$50.00 par value per share.

ARTICLE V

ARTICLE VI

The Corporation shall have at least one director.

ARTICLE VII

No director or officer of the Corporation shall be liable to the Corporation or its stockholders for monetary damages for breach of fiduciary duty as a director or officer, as applicable, except to the extent such an exemption from liability or limitation thereof is not permitted under the Florida Statutes as presently in effect or as the same may hereafter be amended. No amendment to or repeal of this provision shall apply to or have any effect on the liability or alleged liability of any director or officer of the Corporation for or with respect to any acts or omissions of such director or officer occurring prior to such amendment or repeal.

- 3. This Amended and Restated Articles of Incorporation was duly adopted by the Corporation on November 28, 2022.
- 4. The Board of Directors and the sole stockholder of the Corporation have, by joint unanimous consent or by meeting duly held, duly adopted this Amendment and Restatement by the affirmative votes of each the Board of Directors and the sole stockholder, and thereby ratified and confirmed the matters set forth herein.
