Dear Reinstatement Section:

Today, while we were filling out and mailing our Corporate, Federal, and State tax returns, it occurred to us that we did not receive a Division of Corporations filing form. In the thirty-four years since our corporation has been in business, we have taken pride in promptly paying our bills. Your agency sends us the form, we put the form in our accounts payable file, and have a long record of paying our bills on time.

This year we moved our small corporate office to 6345 Plumosa Avenue, Fort Myers, Florida 33908. We notified the post office in Miami Shores of our change of address and we have been regularly receiving our mail.

When we noticed we did not receive the form, my first thought was perhaps the State of Florida has rescinded this fee so today I called your office. I spoke with Rob who is a manager there. He instructed me to download the form, write a letter explaining that we did not receive the form, mention that we inquired as to why we had not received the form from your agency rather than our having received a late notice, and mail the form and the explanation letter with a check for \$ 150.00. Rob also verified our prompt paying record. When we were not able to download the UBR form, we called back and we were told it would be okay for us to white out last year's form and then correctly fill in the information. Please change our address in your records.

In order to prevent this from happening in the future, today we made a new tax return calendar with all the various Federal, State, and County fee due dates. Somehow on our old sheet your due date was typed July 1st.

We are just a small "Mom and Pop" company who has lost money for the last nine years since Hurricane Andrew hit Miami. That is the reason we moved. Your help in waving any penalty would be greatly appreciated.
