Capital Stock

The total number of shares of capital stock that the Corporation shall be authorized to issue is 35,850 common shares, without par value, 717 of which shall be voting common shares and 35,133 of which shall be nonvoting common shares. Voting common shares and nonvoting common shares shall have the same rights and privileges except that the nonvoting common shares shall have no voting rights unless otherwise provided by law.


